DIRECTIONS FOR USE

AFFINITY® TANKMIX, AFFINITY® BROADSPEC or ALLY® EXTRA can be tank mixed with 10.5 to 14 fluid ounces per acre of Cleanwave herbicide for improved Kochia and broadleaf weed control in wheat. Apply from the 3-leaf crop growth stage up through early jointing (Zadoks scale 30).

SURFACTANTS

Unless otherwise specified, add a DuPont recommended nonionic surfactant having at least 80% active ingredient at 1 to 2 qt per 100 gal of spray solution (0.25 to 0.5% v/v) when AFFINITY® TANKMIX, AFFINITY® BROADSPEC or ALLY® EXTRA is used in a tank mix with Cleanwave.

Consult your agricultural dealer, applicator, or DuPont representative for a listing of recommended surfactants. Antifoaming agents may be used if needed.

Do not use low rates of liquid nitrogen fertilizer solution as a substitute for surfactant.
