DIRECTIONS FOR USE

AFFINITY® TANKMIX, AFFINITY® BROADSPEC, ALLY® EXTRA, or ALLY® EXTRA SG can be tank mixed with 1/2 to 1 pint per acre of WideMatch¹ or Colt² herbicide for improved Kochia, Canada thistle and broadleaf weed control in wheat and barley. Make applications to Canada thistle when all thistle are 4" to 8" (tall) with 2" to 6" of new growth.

1/2 to 2/3	<2"
2/3 to 1	2 - 4"

SURFACTANTS

Unless otherwise specified, add a DuPont recommended nonionic surfactant having at least 80% active ingredient at 1 to 2 qt per 100 gal of spray solution (0.25 to 0.5% v/v) when AFFINITY® TANKMIX, AFFINITY® BROADSPEC, ALLY® EXTRA, or ALLY® EXTRA SG is used in a tank mix with WideMatch or Colt.

Consult your agricultural dealer, applicator, or DuPont representative for a listing of recommended surfactants. Antifoaming agents may be used if needed.

Do not use low rates of liquid nitrogen fertilizer solution as a substitute for surfactant.
