Assume grower deposits \$100,000 cash on November 20th, 2017.

Terms and Conditions:

TruChoice® Advance Incentive

- TruChoice® Advance will be calculated based on \$8/unit on Corn, \$2/unit on Soybeans, \$4/unit on Sorghum, but no greater than 10% of the Crop Protection prepay cash or credit. Work with your local DuPont Supportive Retailer and Pioneer Sales Agency to apply the TruChoice® Advance incentive to the Pioneer Seed Invoice.
- The 2018 TruChoice® Advance Incentive can be applied through March 30, 2018.
- Growers can also qualify for the 2018 TruChoice® Advantage program, however final payment will subtract the applied TruChoice® Advance Incentive. See 2018 TruChoice® Advantage for full program details.

TruChoice® Early Pay Multiplier

- Retailer-initiated financing through TruChoice® online: grower will receive an Early Pay Multiplier rebate at the end of the year as opposed to upfront buying power.
- TruChoice® Financing enables customers of DuPont, through its subsidiary PHI Financial Services, Inc., to finance their approved DuPont Crop Protection product purchases.

¹Cash can be applied to a Crop Protection prepay account to avoid loan approval.

²Have approved Deferred Payment Loan with adequate credit limit. TruChoice® Financing for 2018 DuPont Crop Protection opens Oct 1, 2017.

⁴**Interest Reimbursement** is a reimbursement of interest accrued between Oct 1, 2017 to Dec 2, 2018 on DuPont Crop Protection products that are financed by Mar 30, 2018 through TruChoice® Financing. Products financed after Mar 30, 2018 will not be eligible for Interest Reimbursement. According to loan terms, the Deferred Payment Loan Agreement must be paid in full, including accrued interest, to receive an interest reimbursement check. The Interest Reimbursement is only based on net purchases of DuPont Crop Protection products. Interest on unspent loan funds will not be reimbursed.

- The 2018 Early Pay Multiplier is available to growers whose business operations are based in Colorado, Connecticut, Delaware, Illinois, Indiana, Iowa, Kansas, Maine, Maryland, Massachusetts, Michigan, Minnesota, Missouri (excluding Bootheel), Montana, Nebraska, New Hampshire, New Jersey, New Mexico, New York, North Dakota, Ohio, Oklahoma, Pennsylvania, Rhode Island, South Dakota, Texas, Vermont, Virginia (counties of Northampton and Accomack), West Virginia, Wisconsin, and Wyoming.
- Any amount of funding toward your DuPont Crop Protection purchases can be financed or prepaid, however a minimum of at least \$15,000 of qualifying DuPont Crop Protection purchases must be reached to receive Early Pay Multiplier minimum incentives and Interest Reimbursement.
- Redeem your Crop Protection prepay cash or credit funds at any participating retailer; transactions must be entered into TruChoiceOnline.com between October 1, 2017 and September 30, 2018.
- Early Pay Multiplier incentive expires March 30, 2018.
