### Rate recommendation

Instigate® 5.25–7.0 oz/A before crop emergence or 5.25–6.0 oz/A for early postemergence

For most soils and application situations the use rate is 6 oz/A

### Application information

- Apply 14 days before planting and up through V2 corn (2 collars).
- For additional burndown and residual weed control tank mix with DuPont™ Cinch® ATZ or Breakfree® NXT ATZ herbicide.
- For control of emerged weeds add NIS or COC.
- When tank mixed with a glyphosate or glufosinate herbicide containing a built-in adjuvant system, no additional surfactant is required.
