DuPont™ Avaunt® insecticide is recommended as a foliar application to control adult Cranberry weevil (*Anthonomus musculus*) in Blueberry.

Apply Avaunt® at 6.0 ounces/acre as a foliar spray based on locally established treatment thresholds. Allow 5 to 7 days to achieve maximum results. Make repeat applications on at 7 to 10 day schedule if monitoring indicates continued adult feeding activity.

If Avaunt® is applied in two consecutive applications; it is recommended to switch to a different mode-of-action insecticide before making another application with Avaunt® to reduce the risk of insect resistance.

The preharvest interval is 7 days.
