



# INSTA STIK™ Quik Set Warranty Submittal Instructions

Follow the instructions here to apply for your 10-, 15- or 20-year INSTA STIK™ Quik Set Warranty. You may complete and submit materials electronically or download forms to complete and submit by fax or mail.

## 1. Complete Pre-Job Qualification Form

Prior to job start, download the Pre-Job Qualification Form. Use a separate Pre-Job Qualification Form for each individual building. Include, when available, drawings (including cuts, details and number of squares for tapered systems), specifications, revisions/change orders and all documents associated with the roof system.

See instructions on the right to submit the Pre-Job Qualification Form and attachments by fax or mail.

## 2. Sign and Return Letter of Intent to Warrant

A Letter of Intent to Warrant, which includes required quantity of INSTA STIK™ Quik Set units and application rates, as well as warranty fee (if applicable) will be sent to you upon approval of your completed Pre-Job Qualification Form. Sign the letter

### IMPORTANT INFORMATION – READ BEFORE PROCEEDING

- 4' x 4' (1.2 m x 1.2 m) polyisocyanurate and expanded polystyrene insulation boards maximum; all other insulation and coverboards are approved
- Foil-faced polyisocyanurate insulation is not compatible with INSTA STIK™ Quik Set
- Lightweight Insulating Concrete is not compatible with INSTA STIK™ Quik Set
- New poured-in-place concrete must cure for 28 days minimum
- Surface and ambient temperature must be 33°F (1°C) and rising

and return it to Dow, where it will be kept on file. Prior to completion of your roofing project, remember to forward to Dow any job changes initiated after submittal of the Pre-Job Qualification Form.

## 3. Complete Job Start/Completion Notice and Submit Invoice Copies and Fees (if applicable)

Upon job completion, download the Job Start/Completion Notice. Verify the job start date, guidelines followed and date of completion, then sign, date and return to Dow along with copies of invoices for INSTA STIK™ Quik Set.

Once all warranty submittal materials have been received and the use and installation of INSTA STIK™ Quik Set has been confirmed, all applicable warranty fees must be paid before Dow Building Solutions will issue the requested 10-, 15- or 20-year warranty.\*
