Description of first aid measures

General advice:

6. ACCIDENTAL RELEASE MEASURES

7. HANDLING AND STORAGE

Precautions for safe handling: Avoid formation of dust cloud, airborne dust, inhalation and ingestion. Do not breathe dust. Keep container closed when not in use.
