Thank you for your interest in Great Stuff Pro[™] and Great Stuff[™] Polyurethane Foam Sealants, supplied by DuPont. Per your request, the following information has been assembled to address your question about these products with respect to recycling the empty aerosol cans.

Empty cans of Great Stuff[™] and Great Stuff Pro[™] are recyclable.

Empty cans of Great Stuff[™] and Great Stuff Pro[™] are not considered hazardous waste per the U.S. EPA RCRA guidelines and Canadian law.

United States of America

Empty aerosol cans

- Any empty Great Stuff Pro[™] and Great Stuff[™] aerosol cans should be handled as nonhazardous per U.S. RCRA and state guidelines. Recycling is recommended.
- Per the U.S. EPA website for hazardous waste regulation, http://www.epa.gov/osw/lawsregs/regs-haz.htm, RCRA federal law provides broad definitions and each state may make variations for what constitutes an empty aerosol can, so please consult your local laws to determine the definition of an empty aerosol can.

Non-empty aerosol cans

Per the U.S. EPA Resource Conservation and Recovery Act (RCRA), a pressurized aerosol can is typically considered a hazardous waste, if disposed of with pressure remaining in the can due to either flammability and/or reactivity (can rupture) properties. Therefore, pressurized Great Stuff Pro[™] and Great Stuff[™] aerosol cans would be considered hazardous if not empty.

<u>Canada</u>

• Canadian laws that define "empty", with regards to aerosol cans, may vary by province. Please consult your local laws.
